



## HOUSTON SPORTS ACCESS COVID-19 WAIVER

The undersigned, on his or her own behalf, and on behalf of the participant(s) identified below understands the United States of America and the State of Texas is currently experiencing a pandemic caused by an infectious disease known as "Covid-19". In consideration of being given access to the Living Stone Church Gyms and facility and being able to participate in various recreational and athletic activities at the Living Stone Church Gyms and facility, the undersigned, on his or her own behalf, and on behalf of the participant(s) identified below hereby acknowledges and agrees as follows:

The undersigned acknowledges that there are inherent risks associated with participation in recreational and athletic activities, programs and leagues, gym and exercise facilities during the Covid-19 pandemic, and on behalf of the undersigned participant(s) named below knowingly and fully assumes all risks, known and unknown, associated with participation in recreational and athletic activities, programs and leagues at Living Stone Church Gyms and facility ran by Houston Sports Access and waives all claims for damage to person or property arising from such participation. This release and waiver covers risks of death, serious injury and property loss whether arising from (i) negligence or carelessness on the part of the persons or entities being released and other participants, or (ii) dangerous or defective equipment.
2. The undersigned certifies that he or she has reviewed the attached "Checklist For Gym/Exercise Facility Patrons" prepared by the Texas Department of State Health Services and understands the protocols therein;
3. The undersigned on his or her behalf and on behalf of any executors, heirs, successors and assigns agrees to follow all health protocols listed in the attached "Checklist For Gym/Exercise Facility Patrons"; 4. The undersigned understands that Houston Sports Access and Living Stone Church Gyms and facility reserves the right to refuse admittance to the gym to any patron who does not follow the guidelines set forth herein or in the attached "Checklist For Gym/Exercise Facility Patrons";
5. The undersigned shall immediately notify Houston Sports Access if any participant has tested positive for Covid-19, the date of the positive test and the last date the participant attended an Houston Sports Access event and Living Stone Church gym and facility;
6. The undersigned acknowledges that this release and waiver of liability will be used and relied upon by the Houston Sports Access and Living Stone Church Gym and facility and that it will govern the undersigned's actions and rights.
